Professional Licensure Disclosure

Nashville State Community College (NSCC) participates in the National Council for State Authorization Reciprocity Agreements (SARA). Nashville State is accredited by the Southern Association of Colleges and Schools Commission on Colleges (SACSCOC). As a member institution of the Tennessee Board of Regents (TBR), the college is regulated by the Tennessee Higher Education Commission (THEC). Nashville State offers courses, associate degrees and certificate programs that may lead to professional licensure and/or certification. Students who complete one of the programs of study listed below at Nashville State Community College have met the curricular requirements to apply for credentialing in Tennessee. Requirements for other states may vary.

If you currently live in a state other than Tennessee or intend to move to a state other than Tennessee and you plan to use the education completed at Nashville State to seek professional licensure in your state, be aware there may be additional requirements

for obtaining licensure. Please contact the appropriate licensing agency in the state where you intend to seek licensure regarding the requirements in that state.

In many professions, licensure is required for entry into that field of specialization. ACOTE® accredited occupational therapy and occupational therapy assistant educational programs satisfy the states' educational requirements in all states, the District of Columbia, and Puerto Rico. Students graduating from an ACOTE® accredited occupational therapy and occupational therapy assistant educational program are eligible to take the National Board for Certification in Occupational Therapy (NBCOT) certification exam and apply for licensure in all states, the District of Columbia, and Puerto Rico. After successful completion of this exam, the individual will be a Certified Occupational Therapy Assistant (COTA). In addition, all states require licensure in order to practice; however, state licenses are usually based on the results of the NBCOT Certification Examination. Note that a felony conviction may affect a graduate's ability to sit for the NBCOT certification examination or attain state licensure.

The Nashville State Surgical Technology Program is accredited by the Commission on Accreditation of Allied Health Education Programs (CAAHEP). The Nashville State Surgical Technology program is in good standing.

Most states do not require that surgical technologists hold a state-issued license to gain employment or practice in the state. However, several do require surgical technologists to hold professional certification to be considered for employment in most contexts. Some states require professional certification and offer a registry. The Certified Surgical Technologist (CST®) certification is recognized nationally and students graduating from a CAAHEP-accredited Surgical Technology educational program are eligible to take the National Board for Surgical Technology and Surgical Assisting (NBSTSA) National Certification exam to become CST® certified—recognized nationally, in the District of Columbia, and Puerto Rico. The Nashville State Surgical Technology Program is accredited by the Commission on Accreditation of Allied Health Education Programs (CAAHEP), located at 9355 113th St. North, Seminole FL 33775. CAAHEP's telephone number (727) 210-2350 and its Web address is www.caahep.org. Graduates of the program are eligible to sit for the National Certifying Examination for Surgical Technologists administered by the National Board of Surgical Technology and Surgical Assisting (NBSTSA). After successful completion of this exam, the individual will be a Certified Surgical Technologist (CST®). Licensure is not required in order to practice. Statutory requirements (if any) are usually based on the results of the NSTSA Certification Examination.
