ESTIMATED EXPENSES

Fees (subject to change) for the 2026-2027 academic year at Nashville State Community College are \$4,118 per semester, with a total of \$8,236 for two semesters. If you attend the summer semester, there will be additional fees. Each July, our governing board increases the effective fees for the next Fall Semester, which begins in August. Medical insurance, as required by our governing board, is required. The insurance cost is currently \$1,856 per year. More information will be provided when you enroll. Books and supplies are not included in your tuition. It is estimated that tuition and living expenses will total \$43,000 per year.

**You must attend school full-time and are not allowed to work. Nashville State Community College has no financial aid for international students.**
